LISA E. DAHILL is Associate Professor of Worship and Christian Spirituality at Trinity Lutheran Seminary, Columbus, Ohio, USA; past chair of the Bonhoeffer: Theology and Social Analysis Group of the American Academy of Religion; and a scholar, translator, and lecturer on Bonhoeffer.
