Christian civilisation in danger. The contribution of Christianity to Western civilisation. The New Testament seems not interested in this problem. Pre-Christian civilisations show independence of high civilisation from Christianity. The complexity of the problem forces upon us a new kind of approach: What is the Christian answer to some fundamental questions underlying all civilisation? Programme of the lectures.

The material and the spiritual, pantheism mediating. The Christian idea of reality determined by the idea of creation. Not materialism, nor the spiritual, nor pantheism. Consequences for the problem of necessity and contingence, freedom and determinism. The "perspectivity" of being, as expressed in Psalm 139.

Objectivism and subjectivism. Attempts to overcome this alternative, in existentialism. Kierkegaard and the Christian conception of Truth. Distinction between Truth and truths. Truth and communion. East and West. Greek conception of eternity. The loss of the Eternal in modern history. The quantification of time, its psychological consequences. Eternity and time in Christian thought. Time-direction, time of decision. Historical time. Evolution and progress. Progress, substitute for the Eternal. Christianity and the idea of progress.

The eschatological solution of the problem.

Primitive collectivism. The rise of individual personality. The Christian idea of personality correlative to communion. Love, not reason, the truly human. The decline of personalism in modern history. Its three major causes, immanentism, individualism, spiritualism-materialism. Its result, materialistic collectivism. The totalitarian state. The guilt of Christianity within this development.

1 - VIII. THE PROBLEM OF JUSTICE

The idea of justice a historical heritage. The *Lex naturae* conception, Greek-Roman and Christian. Progressive dissolution of the idea of divine justice, since Grotius, by rationalism, individualism, and egalitarianism. *Le contrat social*. Its consequences for family, economic life, and the political order. Capitalism and Communism twin brothers. The Christian idea of justice subordinate to Love. It combines with equality unlikeness and, by it, organic unity. Its basis in the Christian idea of creation. The false alternative and the true synthesis.

Different levels of freedom. Freedom as fact and as postulate. Determinism and indeterminism. The rationalist equation of freedom and independence. The Christian idea: dependence on God. The consequences of the rationalist equation. Marxian atheism. Modern independence movements: from nature and from authority. The crisis of marriage. Latent anarchism of the independence idea. The Christian idea puts divine authority first and freedom second. Ecclesiastical authoritarianism.

Culture and creativity. Creativity gift of nature, but its interpretation and direction lies within freedom. Early misgivings about creativity. Prometheus, the Tower of Babel. Positive and critical attitude of Christianity. Misunderstandings about the role of Protestantism. Since the Renaissance supremacy of Creativity. Cult of Genius in Romanticism. Tendency to formalism. Claim to authority disintegrates civilisation into totalitarian spheres. Political totalitarianism the heir of the process. Theonomy integrates the spheres and excludes all kinds of totalitarianism.

2 - I. TECHNICS

Technics as old as man. The problem of technics new, resulting from the technical revolution. Technical man precedes technical revolution. Robinson Crusoe. Effects of the technical revolution on man. The tragic coincidence: technical revolution in the age of secularisation. Means and ends reversed. The spiritual cause of this reversal. The fatal course of technics-towards the abyss? Ethical appeal and education inadequate. The Christian alternative to the technical apocalypse.

2. - II. SCIENCE

Science younger than technics. Its relation to truth. Natural science and *Geisteswissenschaften*. The scientific ethos. Its Christian basis. No necessary conflict with faith. The influence of sin upon science. Scientific mythology. Science and the postulate of "religious neutrality". The value of Christian anthropology for the *Geisteswissenschaften*. Science within the totality of human destiny.

The modern age anti-traditional. Tradition: cultural memory. Christianity and tradition. Christianity guardian of Greek cultural values. Social tradition and social rootlessness. Christianity and change. "Not yet" and "no more". The newness of life in the Gospel. The revolutionary force of Christian faith. Renewal of centre and periphery. Revolutionary conservatism.

Education and community. The Socratic programme of education. Its incomparable influence. Its relation to Christianity. The German idealist idea of *Bildung*. Its aristocratic character. The original Christian idea of education. Its deformation by theological intellectualism. The Reformation ignores the Socratic element. Pestalozzi's rediscovery. Kierkegaard's contribution. Secularist education in our age. The Christian idea in the modern setting.

2 - V. WORK 215

Why do men work? The classical (Aristotelian) conception of work. Its influence in the middle ages. The Marxist idea its counterpart. Luther's rediscovery of vocation. The modern crisis of the "motifs" of work. Its essential causes. Collectivism unable to restore the dignity of work. The Christian conception of work, both as stimulus and as moderating force.

2 - VI. ART 230

Comprehensive conception of "art". The mystery of art deeper than beauty. Imaginary elevation of existence. The danger of aestheticism. The second commandment. "Christian art"? Form primary in art, but art presupposes human depth. Art in relation to Roman Catholic and Protestant religion. Can art survive secularism? The metaphysical basis of passion. Formalism and barbarism. Art and "the sabbath".

2 - VII. WEALTH 244

Material presuppositions of cultural life. Personality and property. The abstract material good, money and credit. Its danger for personality and community. Capitalism according to Marx. Wealth in the light of the Bible. No Biblical system of economics. Ethical interest in economic structure. Communism necessarily

totalitarian. The dilemma of social security and the free society. Christianity and the economic motif. Onesidedness of Max Weber's theory concerning Calvinistic capitalism. Christianity and secularist materialism.

2 - VIII. SOCIAL CUSTOM (SITTE) AND LAW

Destruction of social habit by individualistic rationalism. Social habit basis of personal morality. The New Testament and social habit. Along with artistic "style" social habit destroyed in the last century. Law filling the gap. Natural and positive law. Positivism. Pre-state and state-Law. Gospel and Law. The created order. Equal rights in Stoicism and Christianity. Polarity of personal rights and social obligation. Law and sin. Secularism increases coercive law.

The "division of power". State sovereignty and God-sovereignty. The unlimited state power, the totalitarian state. Power in inter-state relations. The attempts to limit national sovereignty. The universal world state in the light of Christian faith. Culture, power and religion.

2 - X. The Christian Idea of Civilisation and Culture 285

Coming back to the first lecture. What can Christian civilisation mean? Man alone produces civilisation. Essence of civilisation. Its basic motifs. Civilisation human, but not *the* Human. Why it is "formal". The place of civilisation and culture in the Christian conception of life. Some objections answered. The Christian idea: the human above the cultural; the physical-spiritual unity of man; the civic element fundamental, therefore civilisation above culture. The place of tradition and education. The "highest cultural values" – how far? Art and science in the service of God and of man. The present chances for the realisation of the Christian idea.
