G. WILLIAM CARLSON (PhD, University of Minnesota) is Professor of History and Political Science at Bethel University. He is co-author with Diana Magnuson of *Persevere, Läsare and Clarion* (St. Paul, Minnesota: Bethel 125th Anniversary Committee, 1997). He serves as editor of the *Baptist Pietist Clarion* (2002-present) and is the author of numerous articles on Baptist General Conference history, Swedish Pietism, Christianity in the United States, religion in the Soviet Union and comparative evangelical political thought.

ERIC CARLSSON (PhD, University of Wisconsin-Madison) is Lecturer in the Department of History at the University of Wisconsin-Madison. He is currently writing a book on Johann Salomo Semler and the theological Enlightenment in Germany.

CHRISTIAN T. COLLINS WINN (PhD, Drew University) is Associate Professor of Historical and Systematic Theology at Bethel University, St. Paul, MN and a licensed minister in the American Baptist Church (USA). He is the author of *“Jesus is Victor!” The Significance of the Blumhardts for the Theology of Karl Barth* (2008) and is Series Editor of the *Blumhardt Series* (Cascade Press).

TENZAN EAGHLL is a PhD student at the Centre for the Study of Religion at the University of Toronto. His publications and thesis work explore the theological origins of modernity.

PETER C. ERB (PhD, University of Toronto) is Professor Emeritus at Wilfrid Laurier University, Waterloo, Ont. He was Visiting Professor of Catholic Studies through St. Dunstan’s University at the University of Prince Edward Island, Charlottetown, PEI (2005–2009), and continues (from 1973) as the Associate Director of Schwenkfelder Library and Heritage Center, Pennsburg, PA. He is the author and editor of some 15 books and numerous articles on the Radical Reformation, German Pietism, nineteenth-century Catholic thought, German-American religion and culture, and the contemporary novel.

His most recent work is a four-volume critical edition, *The Correspondence of Henry Edward Manning and William Ewart Gladstone: The Complete Correspondence 1833–1891* (Oxford: Oxford University Press, forthcoming 2011).

VICTOR I. EZIGBO (PhD, University of Edinburgh) is Assistant Professor of Contextual and Systematic Theology at Bethel University in St. Paul, MN. He is the author of *Re-Imagining African Christologies: Conversing with the Interpretations and Appropriations of Jesus in Contemporary African Christianity* (2010).

CHRISTOPHER GEHRZ (PhD, Yale University) is Associate Professor of History and coordinator of the *Christianity and Western Culture* program at Bethel University in St. Paul, Minnesota, where he has been recognized with the Faculty Excellence Award for Teaching. His most recent publication is “Recovering a Pietist Understanding of Christian Higher Education,” in the Winter, 2011 issue of *Christian Scholar’s Review*.

GRACIA GRINDAL, Professor of Rhetoric at Luther Seminary in St. Paul, has long been interested in the Pietist movement as it appeared in Scandinavian hymn writers. She graduated with an MFA in poetry from the University of Arkansas in 1969, was professor of English at Luther College in Decorah, IA for 16 years, and came to Luther Seminary in 1984 where she has been ever since. Currently she is working on a book on the Norwegian American Lutheran parsonage tradition.

EMILIE GRIFFIN has written a number of books on Christian conversion, prayer, and the mystical life. A native of New Orleans and a Phi Beta Kappa graduate of Tulane University, she has won fifty awards for creativity. Griffin did graduate theology studies at Notre Dame Seminary, New Orleans. She lives in Alexandria, Louisiana, and serves as a board member and speaker for Renovare’ USA (Denver), and a founding member of the Chrysostom Society (a writers group).

CHRISTOFFER H. GRUNDMANN (Dr. theol. habil., Dr. theol., Mag. theol., University of Hamburg, Hamburg, Germany) is the John R. Eckrich University Professor in Religion and the Healing Arts at Valparaiso University, Valparaiso, IN. He has published widely in the field of medical missions and healing, faith, salvation, and pneumatology. His book *Sent to heal!—Emergence and development of medical missions* (2005), was named among the fifteen outstanding books in Christian World Missions in 2006.

DAVID M. GUSTAFSON (PhD, Linköpings universitet, Sweden) serves as Associate Professor of Ministry at Houston Graduate School of Theology and Adjunct Professor of Christianity at the University of Houston. He is an ordained minister of the Evangelical Free Church of America (ECFA), and has served as associate and senior pastor in Free Churches in Missouri and Illinois. He is a graduate of Trinity Evangelical Divinity School (MDiv, ThM), Fuller Theological Seminary (DMin) and Linköpings universitet in Sweden (PhD).

GEORDAN HAMMOND (PhD, University of Manchester) is Director of the Manchester Wesley Research Centre and Lecturer in Church History and Wesley Studies at Nazarene Theological College, Manchester, UK. He is co-editor of *Wesley and Methodist Studies* and has recently published several articles on John Wesley's experience in Georgia, including "Versions of Primitive Christianity: John Wesley's Relations with the Moravians in Georgia, 1735–1737," *Journal of Moravian History* 6 (2009) 31–60.

PETER GOODWIN HELTZEL (PhD, Boston University) is Associate Professor of Theology at New York Theological Seminary, and an ordained minister in the Christian Church (Disciples of Christ). He is the author of *Jesus and Justice: Evangelicals, Race and American Politics* (2009).

ERIC HOLST (MA in Christian Thought, Bethel Seminary) is a graduate of Bethel Seminary with an interest in Contextual Theology and Christian Education.

SHIRLEY A. MULLEN (PhD, University of Wales; PhD, University of Minnesota) is the president and professor of history at Houghton College. She is the author of *Organized Freethought: The Religion of Unbelief in Victorian Britain* (1987). Her interests in the Enlightenment, spiritual formation, higher education and the Wesleyan legacy come together in her exploration in this volume of John Wesley as well as in her current work at Houghton.

ROGER E. OLSON (PhD, Rice University) is professor of theology at George W. Truett Theological Seminary of Baylor University. He is the author of 13 books including most recently *God in Dispute: Conversations among Great Christian Thinkers* (2010).

ALICE T. OTT (PhD, Trinity International University) is adjunct professor of church history and history at Trinity International University in Deerfield, Illinois. She previously served twenty-one years in Germany with ReachGlobal. She has published several articles in edited volumes on the religious beliefs of George Rapp and the Harmony Society.

KURT W. PETERSON (PhD, The University of Notre Dame) is Associate Professor of History and Chair of the History Department at North Park University in Chicago, IL. His recent publications include *Lincoln's Land: The History of Abraham Lincoln's Coles County Farm* (2008); and "Transforming the Covenant: The Emergence of Ethnic Diversity in A Swedish-American Denomination," *The Covenant Quarterly* (August, 2009).

RICHARD V. PIERARD (PhD, University of Iowa), is professor emeritus of history, Indiana State University, and lives in Hendersonville, North Carolina. He also taught at Gordon College and South Asia Institute of Advanced Christian Studies, Bangalore, India, and was a Fulbright professor at Frankfurt and Halle Universities. Among his recent books are *The Unequal Yoke* (2006) and *Baptists Together in Christ* (2005), and the co-authored *Two Kingdoms: the Church and Culture through the Ages* (1993), *New Millennium Manual* (1999), and *The American Church Experience: A Concise History* (2008).

KYLE A. ROBERTS (PhD, Trinity Evangelical Divinity School) is Associate Professor of Systematic Theology and Lead Faculty of Christian Thought, Bethel Seminary (St. Paul, MN). Roberts has published several chapters on Kierkegaard, the Bible and Modern Theology in the edited series, *Kierkegaard Research: Sources, Reception and Resources* (University of Copenhagen / Ashgate) and presents regularly on issues related to the intersection of theology, philosophy and culture.

MARK SAFSTROM (PhD, University of Washington) is lecturer of Scandinavian Languages and Literatures at the University of Illinois at Urbana-Champaign. His dissertation is titled *The Religious Origins of Democratic Pluralism: Paul Peter Waldenström and the Politics of the Swedish Awakening 1868–1917*. He is also adjunct faculty in church history at North Park Theological Seminary in Chicago, and serves as chief editor of the journal *Pietisten*.

TIMOTHY M. SALO (PhD, Drew University) is Adjunct Professor of World Religions and Philosophy at Centenary College, NJ and Adjunct Professor of Philosophy and Christian Thought at Somerset Christian College, NJ.

GLEN G. SCORGIE (PhD, St. Andrews) is Professor of Theology at Bethel Seminary San Diego. He has written or edited *A Call for Continuity* (1988/2004), *The Challenge of Bible Translation* (2003), *The Journey Back to Eden* (2005), *A Little Guide to Christian Spirituality* (2007), and the *Zondervan Dictionary of Christian Spirituality* (forthcoming 2011).

DOUGLAS H. SHANTZ (PhD, University of Waterloo) is Professor of Christian Thought in the Department of Religious Studies at the University of Calgary, Canada. He has published books and articles in the fields of German Pietism and the Radical Reformation including: *Between Sardis and Philadelphia: the Life and World of Pietist Court Preacher Conrad Bröske* (2008), and *Crautwald and Erasmus: A Study in Humanism and Radical Reform in Sixteenth Century Silesia* (1992).

JAMES D. SMITH III (ThD, Harvard) is Professor of Church History at Bethel Seminary San Diego, and Interim Minister of Pastoral Care at Fletcher Hills Presbyterian Church. He is co-editor of *The Fabric of Early Christianity*, *The Subjective Eye*, the *Encyclopedia of Christian Literature* and the forthcoming *Dictionary of Christian Spirituality*.

R. J. SNELL (PhD, Marquette University) is associate professor of philosophy and director of the philosophy program at Eastern University, Saint Davids, PA. His research areas include the history of philosophy, especially the thought of Thomas Aquinas as appropriated and applied to contemporary discussions in epistemology and ethics. He is the author of *Through a Glass Darkly: Bernard Lonergan and Richard Rorty on Knowing Without a God's-eye View* (2006) and articles on Lonergan, Charles Taylor, and the natural law.

JONATHAN STROM (PhD, University of Chicago) is Associate Professor of Church History at Candler School of Theology, Emory University. He is the author of *Orthodoxy and Reform: The Clergy in Seventeenth Century Rostock* (1999) as well as a number of articles

in various scholarly journals. His research focuses on the late Reformation, Pietism, and the development of early modern religious culture.

ERIC SWENSSON is an ordained Lutheran pastor and an independent researcher in Luther studies and Spener-Francke Pietism. His family background is the Augustana Synod. He researched the Kinderbeten revival during a three month sabbatical in Halle Germany, wrote a thesis and adapted into *Kinderbeten: The Origin, Unfolding and Interpretations of the Silesian Children's Prayer Revival* (2010).

CINDY WESLEY (PhD, McGill University) is currently the Chairperson of the Department of Religion and Philosophy at Lambuth University, where she has taught for almost a decade. She is the author of *The Role of Pietism and Ethnicity in the Formation of the General Conference of German Baptists, 1851–1920* (2008).

PETER JAMES YODER (PhD Candidate, The University of Iowa) earned his Masters of Theological Studies from Reformed Theological Seminary (Charlotte) and has received research fellowships from the Institut für Europäische Geschichte (Mainz), the Herzog-Ernst-Bibliothek and Forschungszentrum (Gotha), and the Franckeschen Stiftungen (Halle). He is currently conducting research on August Hermann Francke's theology of the sacraments.
