David B. Burrell, CSC, is Professor of Comparative Theology, Tangaza College, Nairobi, and Hesburgh Professor Emeritus, University of Notre Dame. He has worked widely on comparative issues in philosophical theology in Judaism, Christianity, and Islam. Recent publications include Faith and Freedom: An Interfaith Perspective (2005), Deconstructing Theodicy (2008), When Faith and Reason Meet (2009), and Learning to Trust in Freedom: Signs from Jewish, Christian, and Muslim Traditions (2010).

Sylvana Chrysakopoulou is a researcher at the Hellenic Parliament Foundation in Athens, Greece, and has taught ancient Greek philosophy at the Universities of Patras and Crete. Robert Fuller is Professor of Religious Studies at Bradley University.
